U.S. stocks closed lower yesterday. The Dow fell more than 100 points, but was well away from its session lows. The market is paying close attention to U.S. President Trump's tariff policy. Last Saturday (February 1), U.S. President Trump announced a 25% tariff on goods from Mexico and Canada and a 10% tax on goods imported from China. The tariff on energy imports from Canada is lower at 10%.

In response, Canada announced 40 retaliatory tariffs, while Mexico said it would explore imposing taxes on U.S. imports. At the same time, the Chinese government said it would file a lawsuit with the World Trade Organization (WTO). Trump also hinted over the weekend that tariffs would be imposed on the EU next.

But on Monday, Mexican President Sheinbaum said that the imposition of U.S. tariffs on Mexico would be delayed for a month. Later, Trump also confirmed the news. Sheinbaum said she reached a series of agreements with Trump. Mexico will immediately dispatch 10,000 National Guard personnel to strengthen northern border patrols to prevent fentanyl and other drugs from being trafficked from Mexico to the United States. The United States is committed to preventing the trafficking of high-performance weapons to Mexico, and teams from both sides will continue to work on security and trade starting today. From that date, the tariff collection plan was suspended for one month.

Why did the market make a "big reversal"? Trump doesn't want to increase tariffs? The market is "confident" that Trump does not really want to impose tariffs. After all, after the election, the

market misjudged that he would first fulfill his promises of tax cuts and deregulation before considering tariff measures.

Although things are calming now, traders still need to remain vigilant given Trump's volatility. The market generally believes: "Today's carrot may become a stick tomorrow." In the future, the market will continue to pay attention to whether the United States, Canada and Mexico can reach a long-term agreement. If this extension is just another "fake shot", the market may once again experience severe fluctuations and volatility will increase again.

Moreover, tariffs may become a long-term policy risk. There are mainly the following points to be wary of. One is that Trump has repeatedly mentioned using tariffs to help finance the federal budget, which would require widespread implementation of tariffs. Second, he warned that companies need to move back to the United States, which will only happen under permanent tariffs. Third, Trump believes that the United States can withstand economic pain, "We have all the oil we need, we have all the trees we need." This kind of resilience is important only under long-term tariffs.

Economists expect that if the United States ultimately implements and maintains such tariffs, U.S. consumer prices will be pushed higher. Economists say that upward pressure on inflation may prompt the Federal Reserve to pause interest rate cuts for the foreseeable future as inflation has yet to fall back to its target.

The Fed's benchmark interest rate affects the cost of borrowing for consumers on credit cards and other types of debt. In this case, the window for the Fed to resume interest rate cuts at any time in the next 12 to 18 months is closed. Of course, economists say the situation is fluid and makes a precise assessment nearly impossible, as the latest deals between the United States and Mexico and Canada show. It currently appears that U.S. tariffs on China will take effect on Tuesday as planned. There is a lot of uncertainty about how policy will unfold.

The implementation of tariffs will directly push up inflation and have a profound impact on the Federal Reserve's interest rate policy. Joe Seydl, senior market economist at J.P. Morgan Private Bank, predicts that if the United States imposes long-term tariffs on Canada, China and Mexico, the U.S. core inflation rate (PCE price index) will increase by 0.5 to 1% by 2026. percentage point. Evercore ISI's research further pointed out that in the absence of tariffs, the PCE inflation rate should have remained at a low level, and if the tariffs take effect, the PCE inflation rate is expected to be pushed up by about 0.7 percentage points by the fourth quarter of 2025, Reaching about 2.8%.

This is significant for markets because the Fed relies primarily on interest rate policy to control inflation and the labor market. Amid rising inflationary pressures, the Fed may have to keep interest rates high for longer, or even raise interest rates further. The Evercore ISI report clearly states that if tariffs are fully implemented, the possibility of the Federal Reserve cutting interest rates at least once or even twice in 2024 will disappear, thus tightening liquidity and putting financial markets under greater pressure.



The adjustment of the U.S. stock market has been unstoppable. As the professor shared yesterday, the stock market is currently facing high valuation pressure, the disappearance of core driving forces and the comprehensive escalation of the trade war, which is pushing the market into an accelerated decline stage.
